THIS RECREATIONAL BONFIRE PERMIT SHALL BE SUBJECT TO THE FOLLOWING CONDITIONS:

1. ALL BURNING WILL TAKE PLACE BETWEEN THE HOURS OF : _____ : _____ .M. TO _____ : _____ .M. AT THE END OF ALL ACTIVITIES, FIRE SHALL BE COMPLETELY EXTINGUISHED. (RECREATIONAL BONFIRE TIME IS TO BE NO LONGER THAN (6) HOURS)
2. ONLY VEGETATION WASTE 6 INCHES IN DIAMETER OR LESS SHALL BE BURNED. (SHOULD BE KEPT TO A 4' BY 4' PILE)
3. THE OPEN BURNING SHOULD BE SUPERVISED AT ALL TIMES AND APPROPRIATE FIRE-FIGHTING EQUIPMENT SHOULD BE ON HAND.
4. NO TRASH, RUBBISH, OR FLAMMABLE LIQUIDS, SHOULD BE USED TO START THE FIRE OR BURNED WITH THE FIRE INCLUDING: RUBBER, TIRES, SHINGLES, VINYL SIDING, TREATED LUMBER, LEAVES, ETC.
5. THE BURNING SHOULD TAKE PLACE UPON THE PREMISES WHERE IT ORIGINATED.
6. UPON RECEIPT OF A COMPLAINT, THE PERMIT WILL BE TERMINATED UNTIL THAT COMPLAINT HAS BE RESOLVED.
7. THE BURNING SHOULD TAKE PLACE UPON THE PREMISES WHERE IT ORIGINATED.
8. THIS PERMIT SHALL EXPIRE: _____
9. THE CITY OF HERCULANEUM SHALL NOT BE LIABLE FOR ANY NEGLIGENT BURNING BY THE ISSUANCE OF THIS PERMIT.
